EDUCATION COMMITTEE

FINANCE COMMITTEE

2013/2014 Amended Budget

The Secretary Treasurer circulated copies of the 2013/2014 Amended Annual Budget and reviewed the major changes between the annual and amended annual budgets.

He also provided an estimate of the SCIDES budget for the remainder of the 2013/2014 school year.

2014/2015 PAC Budget Presentations

The Superintendent reported on the recent 2014/2015 budget presentations given at the PAC meetings. He noted that currently, four presentations have occurred with further presentations planned for next week. He indicated that the goal of the presentations is to gather feedback on the budget process.

PLNet Upgrade

The Superintendent provided an overview of the PLNET upgrade attachments. He noted that the current network challenges are provided in the document. In particular, the current 1990 architecture has been failing to meet requirements and is not a design that is scalable to meet projected growth.

Due to the current network state, the recommendation is to upgrade the network. Along with this upgrade come costs to the district.

Two options were provided from the Ministry of Education. Option one includes taking the capital costs from the Annual Facilities Grant funding and the operating costs from the block funding before allocation to districts. Option two would be to charge each district their costs as they are able to utilize the network.

The Superintendent recommendation was option one. There was general consensus the district move forward with the recommendation.

BUILDING COMMITTEE

Nicola-Canford Modular Project Update

The Superintendent advised that the Nicola-Canford Modular project is moving ahead and at the present time, is on schedule for an end of July completion.

The Chairman noted he recently toured the site and was quite impressed at the progress and is excited about the final product.

STUDENT TRUSTEE REPORTS

Student Trustee Andrew Silbernagel noted the first semester exams just finished. He informed that his leadership class is currently looking at anti-bullying programs

to present to other students. He noted Princeton Secondary School will be hosting a Valentine's Day game contest on February 13, 2014.
